The work jacket with stand-up collar has an anatomically shaped and functional SLIM FIT cut. Functional back panels made of extra-stretchy Tabiflex® material contribute to an even better fit when moving. The work jacket has a zipper, is equipped with 1 zipper chest pocket, 1 zipper pocket on the left sleeve, and 2 convenient zipper side pockets; the width of the sleeves and the bottom hem of the jacket is adjustable with fasteners. The upper left part of the jacket is designed to bear a company logo in the form of either printing or embroidery. The back of the jacket has functional ventilation. Higher visibility is ensured by reflective stripes on the front and back and hi-vis accessories.


